in both cases, by 5.00 p.m. on 14 March 2024.

By submitting such request, you agree and acknowledge that we and/ or our service provider(s) may collect, use and disclose your personal data, as contained in your submitted request or which is otherwise collected from you (or your authorised representative(s)), for the purpose of processing and effecting your request.

Verification for Attendance and Voting

Please be reminded that we will need your **full** name and CDP account number (if applicable) and your proxy(ies)’ or representative(s)’ **full** name and **full** NRIC/ passport number for verification purposes, and your proxy(ies)’ or representative(s)’ NRIC/ passport will need to be produced for sighting at registration at the AGM. This is so as to ensure attendance and voting only by verified individuals. We reserve the right to refuse admittance to the AGM if we are unable to verify your/ your proxy(ies)’ or representative(s)’ identity accurately.
