

## The Islamic Bank of Asia Shareholders Factsheet

- There are a total of 35 investors in The Islamic Bank of Asia. These include DBS Bank, and 34 investors from the Gulf Cooperation Council (GCC) countries. The GCC investors collectively hold a 50 per cent stake in IB Asia.
- DBS Bank retains its majority stake in The Islamic Bank of Asia (IB Asia) at 50 per cent plus one share.
- The investors come from prominent families and industrial groups based in the GCC, and about half of them come from Saudi Arabia and Bahrain.
- They are involved in industries and businesses ranging from construction, travel and food processing to trading, petrochemical and steel fabrication.
- Each GCC investor owns no more than a 5 per cent stake of IB Asia.
- Some of IB Asia's bigger shareholders include:

- **Dubai Investments (DI)**

A publicly-listed investment company that lists the government of Dubai and National Bank of Dubai as investors and has business interests ranging from agriculture to telecommunications

- **Zamil Group**

An international conglomerate that grew from a trading house in the 1930s to an organisation with diverse industrial and commercial interests ranging from steel fabrication to travel services
