

Terms and Conditions for POSB Everyday Card – SPC LEVO Petrol Promotion 2011 for POSB Everyday Cardmembers

1. Eligibility

- 1.1 The **POSB Everyday Card – SPC LEVO Petrol Promotion 2011** ("Promotion") is conducted by DBS Bank Ltd ("DBS") and is open to all (except those persons listed under paragraph 1.2) eligible cardmembers of POSB Everyday Card ("Cardmembers") whose card accounts are valid, subsisting and in good standing as may be determined by DBS at its sole and absolute discretion.
- 1.2 The following persons are not entitled to participate and are disqualified from the Promotion:
 - Cardmembers whose card accounts have been suspended, cancelled or terminated by DBS at any time during the Promotion Period (as defined below).

2. Free SPC LEVO Tissue Box

- 2.1 The Promotion Period starts from 1 Dec 2011 on a first-come-first- served and while-stocks-last basis.
- 2.2 To be eligible for the free SPC LEVO tissue box, Cardmembers must charge a minimum of S\$50 in a single receipt at any SPC station to a POSB Everyday Card, during the Promotion Period ("Transaction").
- 2.3 Each eligible Cardmember will receive one (1) SPC LEVO tissue box per eligible Transaction.

3. S\$500 SPC Vouchers

- 3.1 Cardmembers must collect 4 **SPC LEVO** tissue box tabs with letters L-E-V-O and proceed to any SPC station to redeem the winner's letter.
- 3.2 Winners of the S\$500 SPC voucher must present his/her NRIC or Passport and the 4 tissue box tabs with letters L-E-V-O at the designated redemption venue as stated in the winner's letter. Collection of S\$500 SPC vouchers must be made by **31 Jan 2012**. No extensions are allowed. Prizes are non-transferable and not exchangeable for cash.

4. General

- 4.1 DBS is not an agent of any merchant. Any dispute about the quality, merchantability and fitness for purpose of the merchant's goods and services must be resolved directly with the merchant.
- 4.2 DBS will not be responsible for any injuries, loss, claim or damage suffered or incurred in connection with the prizes and/or the Promotion (including but not limited to any error in computing any Transaction, any breakdown or malfunction in any computer system or equipment) and/or any notice which is misdirected or lost in the post.
- 4.3 The winner consents to DBS disclosing and/or publishing his/her name and any other of his/her particulars in any manner which DBS may deem fit for publicity purposes. The winner shall cooperate with and participate in such publicity activity organised by DBS for these purposes. The failure by the winner to comply with this clause shall result in his/her disqualification.
- 4.4 DBS' decision on all matters relating to the Promotion (including but not limited to the appropriate number of entries to be awarded to any Cardmember, and the selection of the winners) shall be final and binding. Except for the notification of the cash prize winners (after any verification as may be required has been completed), DBS shall not be obliged to enter into any correspondence on any matter with any party concerning the Promotion.

- 4.4 DBS may vary these terms and conditions without notice, or withdraw or discontinue the Promotion at any time without any notice or liability to any party.
- 4.5 In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail.
- 4.6 These Terms and Conditions are governed under Singapore law and the parties agree to submit to the exclusive jurisdiction of the Singapore courts.
- 4.7 A person who is not a party to these terms may not enforce any of them under the Contracts (Rights of Third Parties) Act (Chapter 53B) and notwithstanding any term of the Promotion, the consent of any third party is not required for any variation of the terms of the Promotion (including any release or compromise of any liability) or termination of the Promotion.
