



## **Score Instant Treats with DBS Cashline!**

### **Terms & Conditions**

#### **Eligibility**

1. Score Instant Treats with DBS Cashline (“Draw”) applies to all DBS Cashline customers (“Customers”) who use DBS Cashline as a mode of payment at selected AXS machines from 1<sup>st</sup> November 2011 to 31<sup>st</sup> January 2012, both dates inclusive (“the Qualifying Period”) . Payments made via e-Assistant are not eligible for the Draw.
2. The Draw is only open to existing DBS Cashline Customers with annual income of S\$30,000 and above at the time of application.
3. The Bank may, where reasonable, exclude certain Customers from the Draw without notice.
4. After each successful payment of at least S\$100 using DBS Cashline via AXS, Customers will be brought to the Score Instant Treats page. Customers will have to select the “Play” button before proceeding with the Draw.
5. Each transaction made using DBS Cashline entitles Customers to 1 Draw chance.
6. There is no limit on the number of chances a Customer is entitled to per month, Customer must first fulfill conditions stated in these Terms and Conditions.
7. Any Prize(s) won will be printed on the AXS receipt in relation to the Cashline payment that the Customer has made.
8. Only original AXS receipt with visible details of the Prize won will be accepted.
9. DBS is not liable for any failure or incompleteness of participation of the Draw via AXS.
10. In the event DBS awards a winner a prize based on invalid, incorrect, inaccurate or falsified Transaction Details, DBS shall be entitled to charge an amount equivalent to the value of the prize awarded to the winner’s Cashline Account without notice.

#### **Draw Prize, Chances & Draw Dates**

11. The Qualifying Period will start on the 1<sup>st</sup> November 2011 and end on the 31<sup>st</sup> January 2012.
12. To qualify for the Draw, Customers must use DBS Cashline at any AXS machine as a mode of payment within the Qualifying Period. Minimum amount of S\$100 per transaction must be used to make payments.
13. The prizes to be won (“Prizes”, and each a “Prize”) include:
  - a) Free regular Brew-of-the-Day worth S\$3.60 at SPINELLI.
  - b) Free 1-for-1 Large Signature Beverage OR 1-for-1 Stew at SPINELLI.

- vi. Offer will have to be redeemed within 2 months from the date printed on the AXS receipt.
- vii. Torn or damaged receipt will be considered invalid.
- viii. Offer is non-exchangeable for cash.

- i. Valid for one (1) year from the date of issue.
- ii. Valid at all Golden Village Singapore Cinemas for one time use only
- iii. Valid for all days and sessions.

- vi. No guaranteed seating.

- x. Golden Village will not be responsible for any lost vouchers.
- xi. Expired vouchers will not be accepted and no revalidation requests will be entertained.
- xii. Prize will be sent to the winner's billing address within 14 days from the date printed on the AXS receipt.
- xiii. Notwithstanding Clause 10 herein, any winner who has given an invalid, incomplete or inaccurate NRIC number or passport number will result in the forfeiture of his/her Prize.

## **General**

The Bank shall not be liable in any way to any customer for any loss or damage arising out of or in connection with the Draw, including any error in computing, any breakdown or malfunction in any computer system or equipment (including but not limited to AXS machines) and any notice which is misdirected or lost in the post.
