Inflection point in sight

Company Overview

Meituan (3690 HK) is China's leading online food delivery and local service platform, with c.5mn riders and c.9m active merchants. Founded in 2010 by Wang Xing, Meituan (a discounting platform) completed a merger with Dianping (an online review platform) in 2015. The company currently owns several APPs, including Meituan, Dianping, Meituan Maicai. It offers online services ranging from food delivery and on-demand delivery service to in-store, hotel and travel bookings. It derives revenue primarily from food delivery service, commission and advertising.

Investment Overview

Meituan operates an extensive fulfilment network of ~7.5mn riders and over 10mn active merchants. Management guided food delivery on track to achieve breakeven in 2Q26, with April and May already recording slight UE profitability. We expect Meituan to retain its leading position, supported by superior supply chain capabilities and differentiated value-for-money offerings such as Pin Hao Fan. We forecast 10% food delivery revenue CAGR between FY25–27F.

Leadership in high-value order maintained. Meituan continues to command over 70% market share in high order ticket clients (>RMB30), with the UE gap versus key competitor widening to Rmb3 per order. Management expressed confidence that UE can return to Rmb1 per order if competitors move toward profitability, with a sustainable long-term gap of Rmb1–1.5. For instashopping, 2Q26 losses are expected to remain below Rmb1bn with orders and GTV market share stable at ~60%. We expect the operating profit for CLC to turn positive in 2Q26, mainly driven by reduced losses of the food delivery.

Overseas expansion gaining traction. Saudi Arabia is guided to achieve monthly breakeven this year and full-year breakeven in 2027, while the broader Middle East is expected to achieve monthly UE breakeven by late 2027 or 2028. New business revenue growth is guided to improve to +22–24% y/y in 2Q26, with segment losses to remain at Rmb2.3–2.5bn due to new market investment. Overall new initiatives annual losses are expected to be contained within Rmb8–10bn.

Maintain BUY with a higher TP of HKD125 (prev: HKD119). We revise up FY26/27F earnings by 4%/6% to reflect faster-than-expected food delivery profitability improvement and a more disciplined investment approach in in-store. Our TP is based on a SOTP valuation: (1) CLC: unchanged 13x FY27F core earnings (HKD96); and (2) new initiatives: 1x FY27F forward P/S (HKD28). Maintain BUY as we believe Meituan's leading position in the food delivery segment remains structurally intact, and we like the long-term profitability potential of Keeta in overseas markets. We believe any further signs of food delivery subsidies scaling back will be a key catalyst.

Risks

- (1) Continuous irrational market competition leading to higher subsidies and
- (2) government regulatory risks.

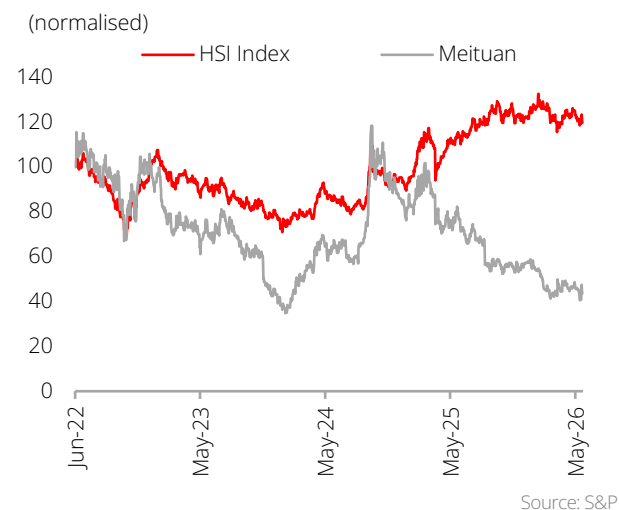
