- This program only available for DBSI new customers who haven't applied and had any other DBSI products (e.g., Tabungan, KTA, etc.) and is applying for digibank VISA Live Fresh Digital Credit Card, digibank VISA Travel Platinum Digital Credit Card, and digibank Black Mastercard World Digital Credit Card through DBSI Website.
- 2. This program is not valid for customer who applied Supplementary Card.
- 3. E-Voucher cashback is a cashback that is given in an E-Voucher form where it can be used for transactions as long as the usage is in accordance with E-Voucher terms of use. Credit Cashback is a cashback that is given in a credit form to the Card account, hence, it can decrease the Credit Card bill.
