

Terms and Conditions for SuperCard Anniversary Campaign – Bajaj Finserv DBS Bank SuperCard





<u>Terms & Conditions for 2X rewards offer on 1 year anniversary of the Bajaj Finserv DBS SuperCard</u>

<u>Offer:</u> The Offer means Eligible Customers will receive 2X reward points. The Offer is applicable on all spends i.e. every purchase transaction' using their Bajaj Finserv DBS SuperCard ('Credit Card') during the Offer Period.

Offer Period: Offer is valid from 3rd April to 8th April, both days included.

<u>Customer Eligibility:</u> The Offer is only applicable DBS's Credit Card holders. Credit Card holders who hold an active and valid Credit Card ('Cardholder') and who have successfully carried out the transactions described in the Offer will qualify for the benefit under the Offer.

Offer T&Cs:

- 1. This Offer is being brought to you by DBS Bank India Limited ("DBS").
- 2. During the Offer Period, customer shall be entitled for 2X reward points if they use their Credit Card for purchase spends i.e. Credit Card holder earn 4 Cash Points (reward points) on every INR 200 spent for all spends apart from fuel spends and cash withdrawals. All Cash points will be round down to calculate the Cash points. The Cash Points earned against purchases made on the credit card shall reflect in the customer's card account on posting of the transaction to the customer's card account.
- 3. The 2X reward points will be calculated on the existing card features If the eligible customer uses Credit Card which gives 2 Cash Points per INR 200 spent, then the customer will receive 4 Cash Points per INR 200 spent during the Offer Period.
- 4. This Offer cannot be clubbed with any other DBS offer/promotion.
- 5. Customers will receive the Cash Points within 90 days from the date when the Offer ends.
- 6. In case the Cardholder cancels any transactions due to which he/she has qualified for the Cash Points under this Offer, then those transactions will not be considered in the calculation of the additional Cash Points.

Cash Point T&Cs:

In addition to existing terms and conditions under the Cardmember Agreement, following terms and conditions apply to the Cash Points:

- 1. Cash Points can be redeemed in the following ways:
 - a. Redemption for gift vouchers via DBS Cards+IN App
 - b. Redemption against Hotel booking via DBS Cards+IN App

- 2. Cash Points are valid only for 2 years from the date of accrual. e.g.: if you have received Cash Points in the month of May 2020, then the same will expire on 31st May 2022.
- 3. If a Cardholder having negative Cash Point Balance at the time of voluntary closure, then the equivalent value of such negative Cash points will be automatically converted to statement debit and is required to be paid by the Cardholder along with any other dues. Reverse debit will be calculated at 20 paise per Card Point.
- 4. The Points do not constitute property of the Cardholder and are not transferable by operation of law or otherwise to any other person or entity
- 5. Reward point redemption will be restricted if a customer has made no payment beyond 5 days from payment due date
- 6. Reward point balance will be forfeited if a customer has made no payment beyond 30 days from payment due date
- 7. In case of transaction reversal, Cash Points credited (Normal/accelerated) will be reversed
- 8. Cash Points earn will be restricted only up to the credit limit allocated to customer. No Cash Points will be credited for overlimit usage.
- 9. In case of upgrade or downgrade, card variant during the statement generation will be considered and all reward point calculations.
- 10. Cash points accrual is subject to change with a notice of 30 days.
