What's New

- Grab sees limited risk from agentic AI, citing its strong driver and merchant supply network, and control over platform APIs and sees AI as an efficiency driver.
- Fintech breakeven is targeted for 2H26, with long-term EBITDA margins potentially reaching 30–40%, supported by lending scale and operating leverage.
- Autonomous vehicle deployment in early-stage, with 11 AVs in Singapore. Unlike the US, most drivers are locals in Singapore so ride-hailers need to manage job-transition
- We maintain BUY with an unchanged TP of USD5.93. Grab has seen a compression in valuation multiple with on-demand business trading at 13x EV/adj EBITDA, same as Uber despite Grab's far superior growth prospects.

Key takeaways

AI likely to enhance platform efficiency rather than disrupt the on-demand model

The key structural moat in the on-demand sector remains the supply side driver networks and merchant ecosystems, which are difficult to replicate or aggregate externally. In addition, Grab does not allow API scraping or external agent access, limiting the ability for third-party AI aggregators to intermedate the platform. In theory, even if AI agents attempt to compare services across platforms, supply concentration and scale advantages would likely direct most transactions back to Grab Holdings due to its wide coverage.

AI spending already embedded in guidance; operating leverage should offset cost pressures

Grab has been investing in generative AI capabilities through partnerships with OpenAI and Anthropic, with applications spanning merchant tools, operational automation and internal productivity. Management indicated that AI and cloud costs are already incorporated into the company's financial guidance, and while these costs will increase in absolute terms as the platform scales, they are expected to grow slower than revenue. As a result, Grab still expects group margin expansion through operating leverage, supported by scale growth and cost efficiencies.

Fintech profitability in the near term and AV deployment in medium-term are key catalysts

Management reiterated expectations for financial services EBITDA breakeven in 2H26, driven by rapid loan book growth and improving operating leverage. Grab's fintech strategy focuses on merchant and driver lending, which carries lower credit risk than consumer lending. Separately, AV deployment in Southeast Asia is expected to progress gradually, with Grab currently operating 11 AVs in Singapore pilots. Unlike the US, where ride-hailing drivers are often foreign nationals, most drivers in Singapore are locals, highlighting the need to manage job transitions carefully via existing ride-hailing platforms like Grab.

Selected Q&A from the Call

Q: How is Grab approaching AI investment relative to peers like DoorDash and Sea?

A: Grab has already been investing in AI for some time and has incorporated these costs into its financial guidance. AI and cloud expenses will increase as the platform scales, but management expects operating leverage from revenue growth and cost efficiencies to offset these costs.

Q: Is Grab developing AI internally or through partnerships?

A: Grab uses a hybrid approach, working with partners such as OpenAI and Anthropic while customizing AI applications internally. Management highlighted that deploying AI in Southeast Asia requires significant localization, particularly for merchants with varying levels of digital adoption.

Q: What explains the difference between Grab and GoTo in fintech monetization?

A: Grab's financial services strategy differs from GoTo Group in two main ways. First, Grab focuses primarily on merchant and driver lending, while GoTo's lending book is more consumer-oriented. Second, GoTo benefits from funding support through its affiliated digital bank, whereas Grab largely funds its loan book through its own balance sheet.

Q: How does Grab view the potential impact of robotaxis and autonomous vehicles in Southeast Asia?

A: Grab believes the autonomous vehicle (AV) landscape in Southeast Asia differs significantly from the U.S. In many Southeast Asian markets, ride-hailing drivers are local citizens and gig driving represents an important source of employment, which makes regulators more cautious about disruption. As a result, AV adoption will likely be gradual and managed in collaboration with governments.

Q: When could robotaxis become commercially viable in Southeast Asia?

A: Autonomous vehicle deployment is expected to occur gradually, starting in markets such as Singapore where infrastructure and driver costs support the economics. Governments are also cautious about potential job displacement among ride-hailing drivers, meaning adoption will likely involve a phased transition with hybrid fleets of human-driven and autonomous vehicles.

Q: How confident is Grab about fintech breakeven?

A: Management expects the financial services segment to reach EBITDA breakeven in the second half of 2026, supported by strong loan book growth and operating leverage. However, the exact quarter may depend on macro conditions and loan growth trends.
