### What's New

- Secures 10 eco-compliant newbuilds across tankers and bulk carriers, deliveries through 2027–2029
- Expands fleet to 105 vessels, with 53 newbuildings under construction
- Funded via equity co-investment and debt, accelerating capital deployment and return enhancement
- Reiterate BUY; TP SGD0.88; stock offers decent 3% dividend yield

**Building 10 more tankers / bulkers.** Yangzijiang Maritime (YZJ Maritime) has signed contracts for 10 newbuild vessels, including: i) four ~114,000 DWT LR2 product/crude tankers (deliveries in 2028 - 2029), ii) four ~49,800 DWT MR2 product/chemical tankers (2027 - 2028), and iii) two ~40,000 DWT handysize bulk carriers (2028). The vessels will be built by third-party Chinese shipyards to IACS classification standards, incorporating high technical and environmental specifications such as EEDI Phase 3 compliance, with the 49,800 DWT tankers also designed for methanol fuel readiness. The programme will be financed through a mix of equity co-investments and debt, in line with the group's established capital deployment framework.

**Key near term catalyst: value-unlocking vessel sales.** The latest order reinforces the group's growth trajectory and enhances earnings visibility by increasing its fleet to 105 vessels, with a substantial pipeline of 53 newbuildings. The diversified vessel mix and eco-compliant designs position the fleet to capture charter demand amid tightening environmental regulations, while supporting premium asset values. The expansion aligns with Yangzijiang Maritime's capital-cycling strategy, providing flexibility to monetise assets via chartering, leasing, or pre-delivery resale, sustaining returns and mitigating cyclicity across shipping markets. We estimate that newbuild value for the 10 projects totaled ~USD550mn. Assuming an average of 85% stake and 40% equity, YZJ Maritime might fork out ~USD45mn pa in 2026–2029; net gearing should still be manageable at 0.1–0.2x. Potential earnings accretions of up to USD20–30mn pa, from charter income / divestment gains for 10 vessels. Pre-delivery asset sales remain a key re-rating catalyst to watch.
