Such confirmation shall be in form and substance satisfactory to the Bank. We irrevocably authorise the Bank to carry out our obligations in this paragraph in our name and on our behalf.

We acknowledge that the Bank has notified us of the following matters:

- **Provisions in the Banking Act 1959 (Banking Act) for the protection of depositors do not apply to foreign authorised deposit-taking institutions (foreign ADI) including the Bank. For example, depositors with foreign ADIs do not receive the benefit of the following protections:**
 - (i) **Deposits are not covered by the financial claims scheme and are not guaranteed by the Australian Government.**
 - (ii) **Deposits do not receive priority ahead of amounts owed to other creditors. This means that if a foreign ADI# was unable to meet its obligations or suspends payment, its depositors in Australia would not receive priority for repayment of their deposits from the foreign ADI's# assets in**

- (iii) **Australia.** **A foreign ADI is not required to hold assets in Australia to cover its deposit liabilities in Australia. This means that if the foreign ADI was unable to meet its obligations or suspends payment it is uncertain whether depositors would be able to access the full amount of their deposit.**
