- (iv) Mr Nihal Vijaya Devadas Kaviratne CBE, who holds 33,768 shares, abstained from voting on Resolution 7 in respect of his own re-election as Director of the Company.
- (v) Mr Tham Sai Choy, who holds 88,000 shares, abstained from voting on Resolution 9 in respect of his own re-election as Director of the Company.
- (vi) All the Directors of the Company, who collectively hold 2,447,112 shares, abstained from voting on Resolution 13 relating to the authority to grant awards and issue shares under the DBSH Share Plan.
