# 2. Re-appointment of Directors to the Audit Committee

The Company wishes to announce that Mr Chng Kai Fong, Ms Judy Lee and Mr David Ho Hing-Yuen have been re-appointed as members of the Audit Committee. The Board considers Ms Lee and Mr Ho to be independent pursuant to Rule 704(8) of the Listing Manual of the SGX-ST.

Mr Chng is a non-executive non-independent Director and has no management or business relationships with the Company. Mr Chng is considered non-independent from DBSH's substantial shareholder, Temasek Holdings (Private) Limited as the Singapore government is its ultimate owner, and Mr Chng is the Permanent Secretary (Information and Development) for the Ministry of Communications and Information, and concurrently the Permanent Secretary (Development) (Cybersecurity) in the Prime Minister's Office.
