	Qualitative Analysis		

Bank's leverage ratio was 9.25% as of 31 Dec 2023, exceeded the minimum requirement. Increase in Leverage Ratio by 0.29% was supported by the increase in Bank's tier 1 capital by Rp311 billion from previous quarter.
