These Terms and Conditions for investment services ("Terms and Conditions") apply to and govern your usage of DBS investment services. Individual Customers: In case of individual customers, the investments in mutual fund/s can be made through iBanking or by submitting Financial Transaction Form at any nearest DBS Bank India Limited branch for every transaction.
